The Presenter has 550 seats that may be sold. Should it be necessary for sound or lighting to be located in the house, there may be additional seat kills necessary to accommodate this requirement. For each performance the Theatre holds 8 seats for Staff and Volunteers. Wheelchair patrons use 2 seats (removable) to accommodate a wheelchair.

Main Control Booth:	Located at the rear of the house - fully equipped
House Station (mid-house):	Located in row H. Equipped with Ethernet, Clearcom, program sound & AC power
House Station (rear house):	Touring mix location is located in the centre of Rows R & S, seats at the rear of the house, directly in front of the Control Booth. All hook-ups to this position are accessed from the control booth. Sound snake routes from DSR or DSL.

Dressing Room #2 - Shakespeare

Accommodates approximately 20 people; 1 shower, 3 sinks, 2 toilets, 2 rolling costume racks

Green Room – W. O. Mitchell

Accommodates approximately 20 people; microwave, bar fridge, television monitor, tables, chairs, couches and dish washer

There is a stackable washer and dryer in the Theatre.



USE OF HAZARDOUS MATERIALS

Substance Regulations

Government of Canada legislation requires that the use of “controlled” products in our theatres shall comply with the rules under WHMIS (Workplace Hazardous Materials Information System). Controlled products include:

- Compressed Gas
- Flammable and Combustible Material
- Oxidizing Material
- Poisonous and Infectious Material
- Corrosive Material
- Dangerously Reactive Material

WHMIS regulations require that:

- a) Anyone using a controlled product in the workplace must be informed as to its safe storage, handling, use and disposal.
- b) All containers of controlled products must have warning labels attached that meet regulation requirements.
- c) A MSDS (Material Safety Data Sheet) for any controlled product must be available and be maintained in the immediate work area.

Some substances such as explosives, radioactive materials, and tobacco are covered under separate regulations. Smoking in our Theatre, for example, is restricted under our Civic Bylaws to designated areas only.
